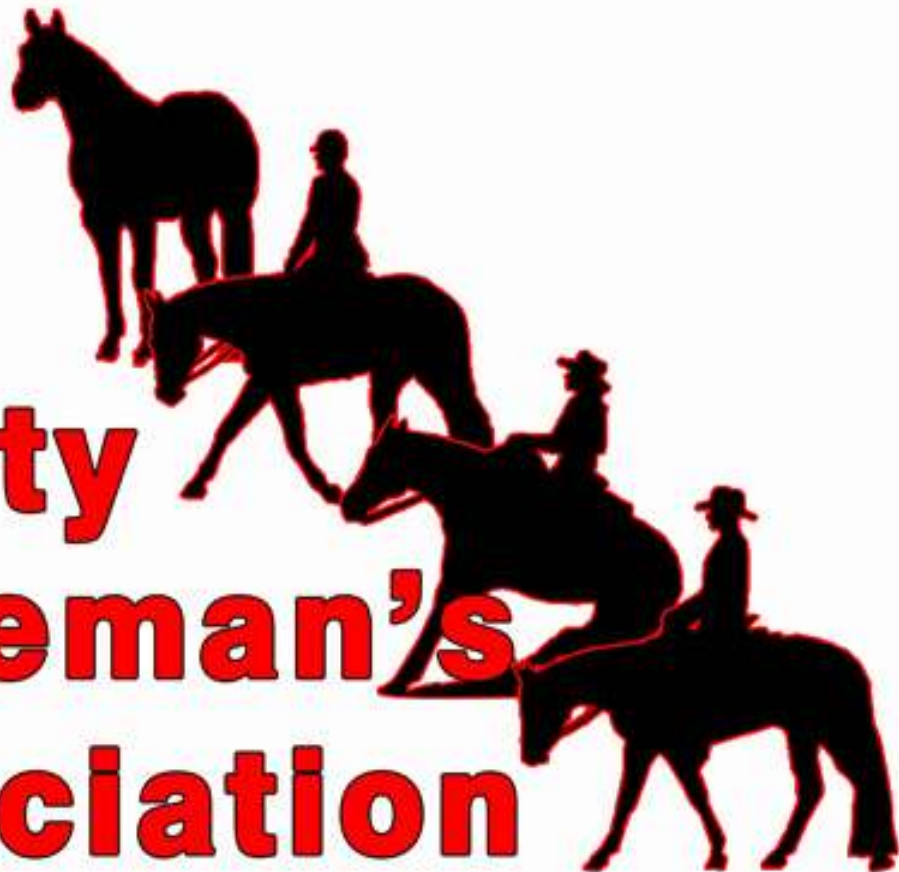

1. Drive Penalties

- Over lifted (per maneuver)
- Out of basin (per maneuver)
- Touch of back or stepping on a leg, ribs, chest or any component of the chest
- Assisted or break of gut of walk or trot for two (2) or less
- Assisted or break for two (2) or less for a single stride or space of a walk or trot
- Stepping over or falling in any (2) or more spaces
- Incorrect number of beats, if specified
- One or two steps or establishments when ground or correct shifting is intended
- Split leg in two (2)

2. Drive Penalties

- Wholly lost or out of lead
- Drop of ribs
- Break of gut of top
- Break of gut of walk or trot for more than two (2) strides
- Three (3) or more establishments or ground

3. Fault Penalties

- Spacing in front or hind
- Head disturbance
- Use of either "lead" to enter baseline
- Kicking over, stepping out of, or cutting off of an obstacle
- Dropping an object required to be carried
- 1 or 2nd cumulative offense
- Lifting up of gait
- 5 or more steps or establishments or ground

4. Fault Penalties

- Unimpaired Head and Appearance (Horse's tail is visible, unobscured by any part of a structural member or body member)

5. Fault Penalties (SPL) - Cannot place above others when corrected

6. Fault Penalties

- Grounding pattern
- Set-back
- Repeated (3) or more disturbances
- Failure to fully and remain settled during the flag
- One of two hands (except in snaffle bit or hackamore)
- More than one finger between split-rein or any finger between reins and bit

7. Disqualification (DQ)

- Abuse
- Unfitness
- Disrespect or disrespect
- Illegal equipment
- Cut of hair/under
- Improper uniform attire
- Leaving arena before pattern is complete

OBSTACLE SCORES

Each obstacle starts a count between 0-10 points and automatically begins to decrease with a count of 75 points
 +10 (Excellent/Max), +7 (Very Good), +5 (Good), +3 (Satisfactory), +1 (Very Fair), -1 (Doubtful)

II. Point Penalties

- Wrong lead or out of lead
- Exceed wire (per measure)
- Break of gait at lope
- Break of gait at walk or trot for more than two (2) strikes
- Out of lead or slow-changing more than two (2) strikes after changing leads
- Trailing back two (two) (2) strikes after making a single lead change
- Slowness or disturbance of any obstacle

III. Point Penalties

- Slowness (disturbance) - (out, too slow, etc.) for each strike

IV. Point Penalties

- Unnatural Manes: Horse Appearance (Penalty will be obvious and consistently applied. Exaggerated heavier in every instance.)

V. Penalties (DQ): Cannot show above others who qualify unless:

- penalty
- disqualify horse
- disqualify horse
- Use of hot irons (except joint and level 1 horses shown in a small introduction), bare this wire (finger between splines or any finger between total wire) except in the turnout.
