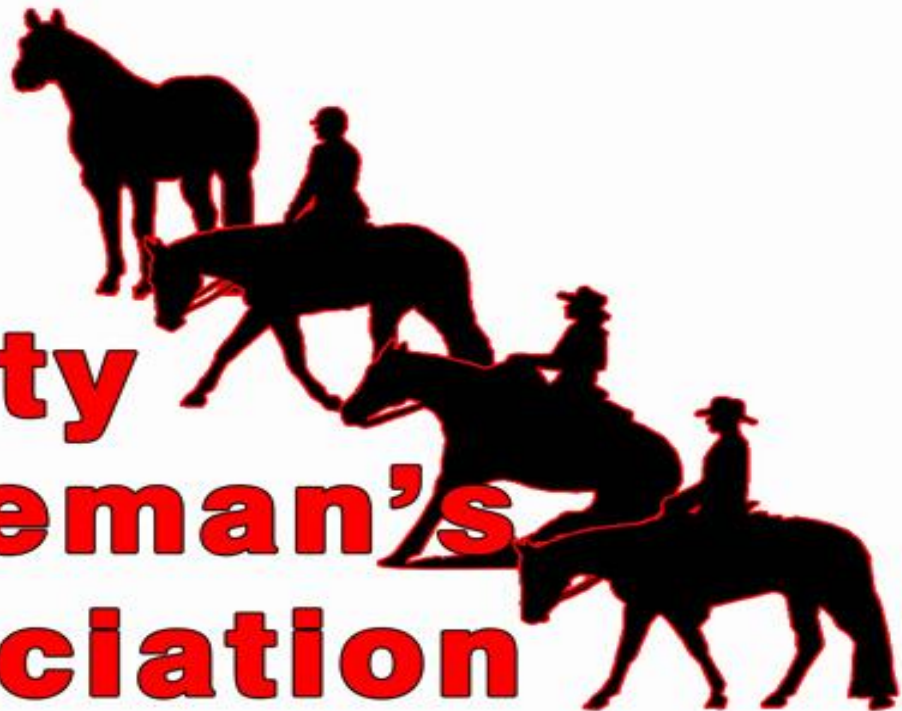

1 Point Penalty:

- Over-bridged (per maneuver)
- Out of line (per maneuver)
- Fall slow (per gait)
- Break of gait or walk or trot or lead (2) strikes or less

2 Point Penalty:

- Bridged or too often
- Dropped reins (per maneuver)
- Break of gait or trot
- Break of gait or lead or lead for more than two (2) strikes
- Out of lead or wrong side reins more than two (2) strikes when changing leads
- Trotting more than three (3) strikes when making a complete lead change
- Failure or disobedience at any obstacle

3 Point Penalty:

- Excess disobedience (kick, bite, back, rear, etc.) for each offense

3 Point Penalty:

- Unnatural Ranch Horse Appearance (3 point for a costume and consistency carried in an unbranded manure in every maneuver)

20 Points (20): Ground stops, stops, starts, etc. when available without penalty:

- Incomplete maneuver
- Incomplete maneuver
- Use of two hands (brake) prior and lead (1 horse shown in a snaffle with a snaffle) more than one finger between spurs or at any finger between manure (as used in the show)

Disqualifying (DQ):

- Illegal equipment including head blocks, brakes or lead devices, or tail extenders
- Illegal noise
- Major disobedience or interfering
- Curiosity

1. Fault Penalties:

- Over/under (per maneuver)
- Out of frame (per maneuver)
- Too slow (per gait)
- Break of gait at walk or trot for two (2) strides or less

2. Fault Penalties:

- Wrong lead or out of lead
- Striped legs (per maneuver)
- Break of gait of lead
- Break of gait at walk or trot for more than two (2) strides
- Out of lead or under-cutting more than two (2) strides when changing leads
- Topping more than three (3) strides when making a single lead change
- Break or disturbance of any stride

3. Fault Penalties:

- Stray (disturbance) (kick, bite, buck, rear, etc.) for each offense

4. Fault Penalties:

- Unnatural Ranch Horse Appearance (Mane/s tail in show and consistently carried in an unnatural manner in every maneuver)

5. Off-Pattern (OP): General rules about others who complete pattern correctly:

- Complete maneuver
- Incomplete maneuver
- Top of two hands (except prior and level 1 horses shown in a profile photograph) more than one finger between gill wire or wry fingers between coral wire (except in the last rule)

6. Disqualifier (DQ):

- Badly equipped including lead back, braced or bented knees, or tailheadbars
- Wild Abuse
- Major disobedience or schooling
- Lateness

1. Point Penalties:

- One-handed (per maneuver)
- Out of frame (per maneuver)
- Top-down (per gait)
- Break of gait or walk or trot for two (2) strides or less

2. Point Penalties:

- Wrong lead or out of lead
- Dropped reins (per maneuver)
- Break of gait at top
- Break of gait at walk or trot for more than two (2) strides
- Out of lead or cross-centering more than two (2) strides when changing leads
- Trading more than three (3) strides when making a single lead change
- Deviate or disturbance of any obstacle

3. Point Penalties:

- Mount dismountance (tick, two, knock over, etc.) for each attempt

11. Point Penalties:

- Unnatural Ranch Horse Appearance (horns to be obvious and consistently carried in an unusual manner in every maneuver)

12. Point Penalties: Cannot place above others who complete pattern correctly

- Complete maneuver
- Incomplete maneuver
- Use of facemask (except prior and/or later than shown in a specific performance), more than one leg between girth rings or any leg(s) between front rings (except at the low-side)

13. Qualifier (Q):

- Regal equipment including hoof block, bridle or bridle mask, or tail extension
- Wrist brace
- Helm disturbance or coloring
- Lantern

- Open-heel (per instructor)
 - Tip of knee (per instructor)
 - Toe clear (per gait)
 - Break of gait at walk or trot to be less (2) strides or less
- 2. Foot Position:**
- Whip held at end of lead
 - Craps (one per maneuver)
 - Break of gait at foot
 - Break of gait at walk or trot to be more than two (2) strides
 - Out of lead or cross-leading more than two (2) strides when changing leads
 - Trailing more than three (3) strides when making a simple lead change
 - Stops or disturbance of any stride
- 3. Foot Position:**
- (Break of stride at 200, 250, 300, 350, 400, 450 for each stride)
- 4. Foot Position:**
- Involved Hand Horse Agreement (horse's tail is obvious and consistently raised in an unobtrusive manner in every movement)
- 5. Pattern (SP):** General rules about others who complete pattern correctly:
- Disruptive movement
 - Disruptive movement
 - Use of two hands (except on one and level 1 horses about a profile adjustment), more than one finger between gait ends or any finger between total nine (9) ends in the turn-outs
- 6. Disqualification (DQ):**
- Illegal equipment including headstall, bridle or banded reins, or tail extensions
 - With Hoof
 - Max disobedience or striking
 - Lameness

1. Point Penalties:

- One o'clock (per maneuver)
- Out of frame (per maneuver)
- Tail size (per gait)
- Break of gait or walk or trot for tail (2) strikes or less

2. Point Penalties:

- Wronglead or out of lead
- Draped reins (per maneuver)
- Break of gait at stop
- Break of gait at walk or trot for more than two (2) strides
- Out of lead at cross-swinging more than two (2) strides when changing leads
- Trailing foot that does (2) strikes when making a single lead change
- Slouch or disturbance of any obstacle

3. Point Penalties:

- Shorter dismounts (JCK, DKL, turn, rear, etc.) for each offset

13. Point Penalties:

- Unnatural Ranch Horse Appearance (horses tail is obvious and completely vertical at unusual angles in every maneuver)

14. Point Penalties (OFF) - Cancel about 4000 others who complete entire circuit:

- Incomplete maneuver
- Incomplete maneuver
- Use of two leads (except prior and level 1 horses shown in a profile performance), more than one leg between split turns or any leg(s) between round turns (except in the low-disk)

Disqualification (DQ):

- Hoop equipment including lead blocks, braided or beaded manes, or tail extensions
- UHF's attire
- Major disobedience or unruly
- Unhorses
