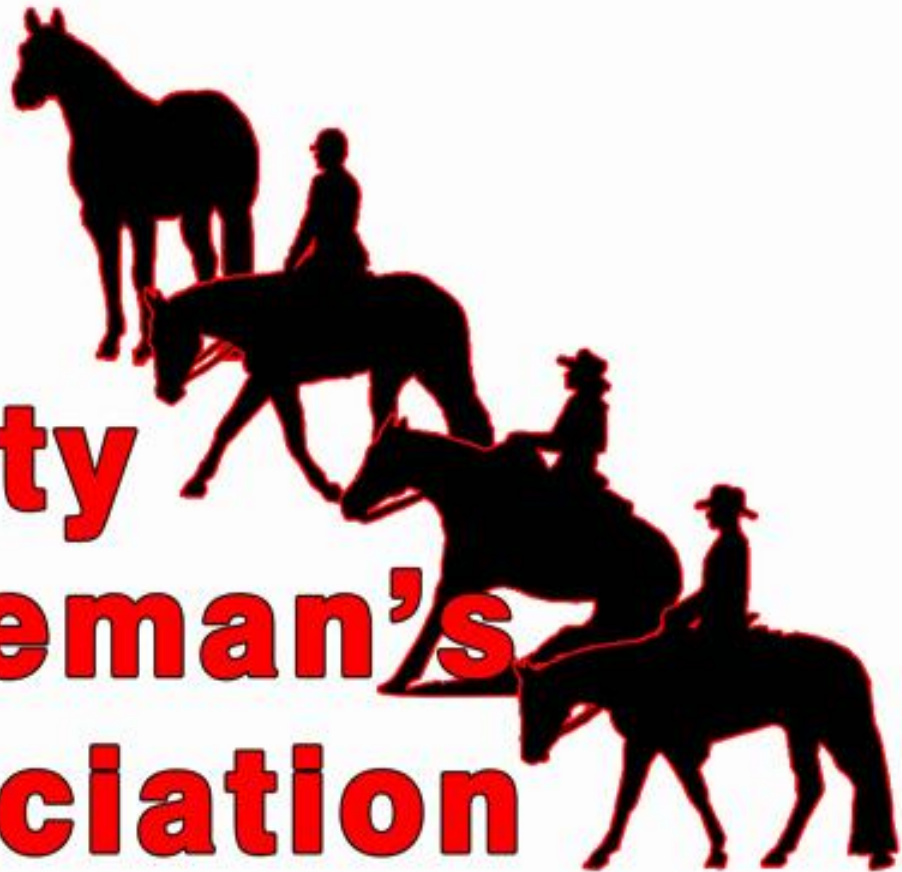

Lead • over-collared (per maneuver) • out of frame (per maneuver) • each bit, bit or slipping on a bit, cone plant or any component of the obstacle • break of gait at walk or trot for 2 strides or less • both front or hind feet in a single stride set or space at a walk or trot • slipping over or falling or stepping into required space • split pace in lope-over • increased number of strides, if specified • 1 to 2 steps on mount/dismount or ground tie escape (riding to balance) • wrong lead or out-of-lead for 2 strides or less	2. Gait • break of gait at walk or trot for more than 2 strides • break of gait at lope, except when ascending an inclined lead • wrong lead or out-of-lead for more than 2 strides • draped reins (per maneuver) • 2 to 4 steps on mount/dismount or ground tie • trotting for more than 2 strides in lope departure or exiting a rollback • mounting over or severely disturbing an obstacle • stepping out of or falling off an obstacle with 1 foot • missing or evading a part of light obstacle with 1 foot	3. Pattern (OP) - to be placed below horses performing all maneuvers • eliminable or wide maneuver • incomplete maneuver • set refusal • repeated/obstinate disobedience • failure to fully and remain stalled during the stop • use of two hands (except lower and 11 horses shown in a snaffle bit tack), more than one finger between split reins or any fingers between normal reins (except in the turning) • failure to open and shut gate or failure to complete gate
4. Standstill • spurring in front of dash • inflated disobedience (kick, bite, back, rear, etc.) for each refusal • use of either hand to assist feet/hooves • stepping out of or falling off an obstacle with more than 1 foot • dropping an object required to be carried • hit or 2nd consecutive refusal • letting go of gate • 2 or more steps on mount/dismount or ground tie • missing or evading a part of light obstacle with more than 1 foot	5. Disposition - Abuse • lameness • disrespect or misconduct • legal equipment • wild steers • leaving working area before pattern is complete • improper number of reins • bit of nonholder

Off Pattern (OP) - to be placed below losses performing all maneuvers

- eliminates or adds maneuver
- incomplete maneuver
- repeated blatant disobedience
- use of two hands (except junior and L1 horses shown in a specific performance), more than one finger between split reins or any fingers between reins (except in the two rein)

Disqualified (D) Horses

- illegal equipment including lead mask, bridle or bitted mane, or bit extensions
- lameness
- disoriented or miscolored
- wild steers
- leaving working area before pattern is complete
- improper western attire
- tail of horse out

2 points

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when contacting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- draped reins (per maneuver)
- out of lead or cross-cantering more than 2 strides when changing leads
- looting more than 2 strides when making a simple lead change
- looting more than 2 strides in lope departures or when exiting a rollback
- severe disturbance of any obstacle

3 points

- severe disobedience (kick, bite, back, rear, etc.) for each refusal

Off-Colors (OC) - to be placed below horses performing all maneuvers

- eliminates all side movement
- incomplete maneuver
- repeated severe disobedience
- eye of the horse (except junior and L1 horses shown in a snaffle (shaded mare), more than one fringe between splines or any fringe between normal ribs (except in the security)

Disqualified - 4 Score

- illegal equipment including hoofblock, latched or banded manes, or tail extensions
- lameness
- shodded or misshodded
- wither strike
- leaving working area before pattern is complete
- improper western attire
- fall of horse/ride

- wrong lead or out of lead for 2 strides or less

Loops

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when correcting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- choppy reins (per maneuver)
- out of lead or cross-cantering more than 2 strides when changing leads
- trotting more than 2 strides when making a simple lead change
- trotting more than 2 strides in lope departures or when calling a rollback
- severe disturbance of any stride

Loops

- Obtain disobedience (kick, bite, back, rear, etc.) for each ritual

Off Pattern (OP) - to be placed below horses performing all maneuvers

- incomplete or odd maneuver
- incomplete maneuver
- exposed lateral disobedience
- use of two hands (except joint and L1 horses shown in a snaffle bit/stockman), more than one finger between split reins or any fingers between normal reins (except in the last rein)

Disqualified - (DQ)

- legal equipment including hoof block, trailer or loaded manes, or tail extensions
- tameness
- derogated or miscolored
- wildful abuse
- leaving working area before pattern is complete
- improper western attire
- bit of horseshoe

 - severe disturbance of any obstacle

 - drugged or misconduct
 - willful abuse
 - leaving working area before pattern is complete
 - improper western attire
 - fall of harness
