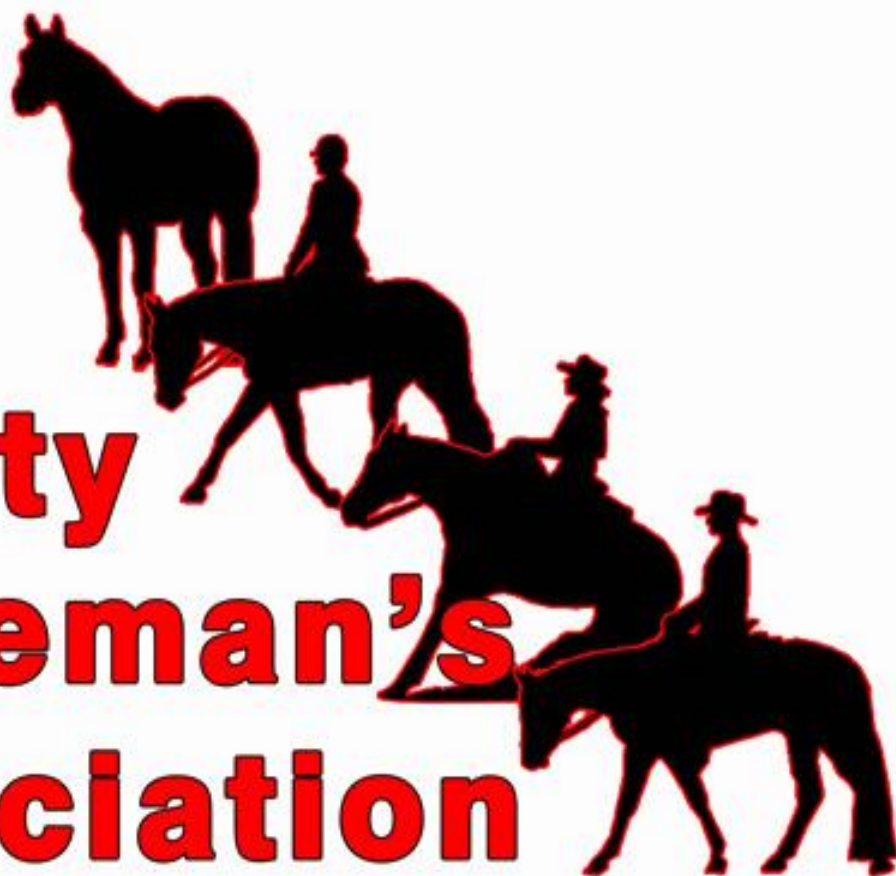

- Logic**
- over leaped (per measured)
 - out of frame (per measured)
 - walked, slip or stepping on a log, cone placed or any component of the obstacle
 - break of gait at walk or trot for 2 strides or less
 - both feet or hind feet in a single stride set or space of a walk or trot
 - stepping over or falling in step into required space
 - gilt gate in top-line
 - incorrect number of strides, if specified
 - 1 to 2 steps on roundabout or ground tie except shifting to tolerance
 - wrong lead or out of lead for 2 strides or less
- Penalty**
- break of gait at walk or trot for more than 2 strides
 - break of gait at lope, except when ascending an inclined lead
 - wrong lead or out of lead for more than 2 strides
 - stepped into (per measured)
 - 2 to 4 steps on roundabout or ground tie
 - falling for more than 2 strides in top-line position or setting a cutoff
 - breaking over or severely disturbing an obstacle
 - stepping out of or falling off an obstacle with 1 foot
 - stepping or swaying a part of leg/hoof with 1 foot
- Penalty**
- spurring in face of neck
 - hazardous behavior (kick, bite, buck, rear, etc.) for each infraction
 - use of whip hand to control
 - stepping out of or falling off an obstacle with more than 1 foot
 - dropping an object required to be carried
 - 1st or 3rd cumulative infraction
 - letting go of gate
 - 2 or more steps on roundabout or ground tie
 - stepping or swaying a part of leg/hoof with more than 1 foot
- Disqualified 2 Strides**
- lameness
 - disrupted or unbalanced
 - illegal equipment
 - with 2 strides
 - leaving working area before pattern is complete
 - improper western attire
 - fall of tail/head
- On Pattern (OP)** - to be placed below horses performing all maneuvers
- attempts or ends maneuver
 - incomplete maneuver
 - 3rd release
 - repeated severe disturbances
 - failure to fully and safely dismount during the stop
 - use of two hands (except jump) and 11 fingers shown in a snaffle bit/ backband, more than one finger between split reins or any fingers between split reins placed in the backband
 - failure to open and shut eyes, or failure to complete gate

- spurring in heat of clash

- use of either hand to assist backside
- stepping out of or falling off an obstacle with more than 1 foot
- dropping an object required to be carried
- 1st or 2nd combination rebound
- falling go of pole
- 4 or more steps at roundabout or ground tie
- missing or missing a part of lightside with more than 1 foot

01 Pattern: 001 - to be performed by horses performing all maneuvers

- alternate or split maneuver
- acceptable maneuver
- 2nd rebound
- repeated default disobedience
- failure to fully and evenly flatten during the stop
- use of two hands (except prior and LT horses shown in a walk/trot backside), more than one finger between upper teeth or any fingers between lower teeth (except in the two-hold)
- failure to open and shut gate or failure to complete gate

Disqualified: 1.0000

- bitterness
- disregard or disrespect
- illegal equipment
- illegal stance
- leaving working area before pattern is complete
- improper western attire
- lat of furniture

- Unusual Ranch Horse Appearance (Horse's vital to-do's and condition carried in an unusual manner in every maneuver)
- 20 Point Penalties (OP):** Cannot please show, affects into complete pattern, correctly
- Incomplete maneuver
 - Incomplete maneuver
 - Use of two hands (except junior and level 1 horses shown in a profile (with backbars), more than one finger between split reins or any fingers between round reins (except in the low ride).
- Classifications (CC):**
- Illegal equipment including hood/neck, braided or braided manes, or tail extensions
 - Vital Abuse
 - Bride-battering or schooling
 - Lameness

- use of two hands (except for and 11 times shown in a snaffle without lacing), more than one finger between split reins or any fingers between round reins (except in the two rein)

Disqualified - 5 Stars

- Illegal equipment including lead blocks, cracked or bented manes, or tail extensions
- tameness
- deranged or recouped
- wild voice
- leaving working area before pattern is complete
- stranger wears attire
- id of horse/ rider

- wrong lead or out of lead for more than 2 strides
- mixed reins (per movement)
- out of lead or cross-cantering more than 2 strides when changing back
- holding more than 2 strides when making a single lead change
- holding more than 3 strides in place departures or when riding a rollback
- severe disturbance of any obstacle

Leads

- failed disturbance (set, slip, back, etc.) for each obstacle

Off Pattern (OP) - to be placed below horse performing all maneuvers

- alteration in aids/movement
- incomplete maneuver
- repeated lateral disturbance
- use of two hands (except prior and L1 horses shown in a snaffle bit/halter), more than one finger between split reins or any fingers between total reins (except in the two lead)

Disqualified - 4 Stars

- illegal equipment including hoofcaps, brided or banded manes, or tail extensions
- lameness
- dropped or miscontact
- willful driver
- leaving working area before pattern is complete
- improper written aids
- fail of horse/ride

- one strike (per gait)
- two strikes (per maneuver)
- out of lead (per maneuver)
- break of gait at walk or trot for 2 strikes or less
- wrong lead at end of lead for 2 strikes or less

2. Gait

- break of gait at walk or trot for more than 2 strikes
- break of gait at lope, through when crossing an incorrect lead
- wrong lead at end of lead for more than 2 strikes
- strapped sides (per maneuver)
- out of lead at cross-canter more than 2 strikes when changing leads
- falling more than 3 strikes when making a simple lead change
- falling more than 3 strikes in face departures or when entering a ribback
- severe disturbances of any obstacle

3. Pattern

- strapped shoulders (gait, side, back, rear, etc.) for each obstacle

OT Pattern 12B - To be placed below horses performing all maneuvers

- eliminates of walk maneuver
- incorrectly maneuver
- incorrect/unsafe dismount
- one of two hands (except posts and 1) moves when in a profile (Whispering), more than one finger between splinters or any fingers between oral ribs (except in the breast)

Disqualified - 0 Score

- illegal equipment including headstall, bridle or bridled mane, or tail extension
- lemons
- disrupted or interrupted
- illegal stance
- leaving working area before pattern is complete
- incorrect western attire
- fall of horse/riders

- use of two hands (except joint and 11) times shown in a snaffle bit (backbone), more than one finger between girth reins or any fingers between normal reins (except in the rear seat)

Disqualified - 6 Score

- legal equipment including hoof block, braded or leaded manes, or tail extensions
- lameness
- deranged or misrouted
- withdrew
- leaving working area before pattern is complete
- inappropriate attire
- ill of horse/ rider
